



FEE SCHEDULE

ENROLMENT APPLICATION FEE \$60

A non-refundable fee is payable per student at the time of submitting a formal Application for Enrolment

ENROLMENT CONFIRMATION FEE \$150

A non-refundable confirmation fee is payable per student at confirmation of enrolment. No refund of this fee shall be made by the school should a student fail to utilise a confirmed place. This fee is not deducted from tuition fees.

TUITION FEE POLICIES

Each family will receive a full account for the year in February 2018. All accounts will be sent out electronically.

1. FEE PAYMENT OPTIONS

- Payment via Westpac Direct Debit either:
 - annually by Friday 16th February to receive the Early Payment Discount
 - pay each term in full by second Friday of each term (part-payments will not be accepted). No discounts are available for this payment option.
 - 40 weekly payments, 20 fortnightly payments or 10 monthly payments over the course of the school year.
- Regardless of payment frequently selected, all 2018 and prior school fees must be paid in full by the conclusion by November 29th, 2018.

2. JOINT AND SEVERAL LIABILITY FOR TUITION FEES

All parents/guardians, including step-parents, who have signed a Confirmation of Enrolment, are jointly and severally liable for the payment of all fees and other charges related to the education of their student/s at GSCS. GSCS does not split bill except where a court order is in place.

3. UNPAID TUITION FEES

Consistently unpaid fees will put the enrolment of your child/ren at GSCS in jeopardy. If an enrolment is discontinued, unpaid fees will still be a debt due and owing to GSCS.

If any unpaid account remains outstanding without an approved arrangement with our Business Manager, we then reserve the right to require such families to enter into a contract of payment as a condition of continuing enrolment. In the event of any account balance being outstanding at the end of the calendar year, GSCS reserves the right to apply a 10% service charge of the outstanding balance of the account.

4. WITHDRAWAL FROM GSCS

GSCS must receive a full term's written notice for the withdrawal of a student, otherwise a full term's fees will be charged in lieu of notice.

5. FINANCIAL ASSISTANCE SCHEME

GSCS retains a general policy that children should not be prevented from having a Christ-centred Christian education due to family financial difficulties or changes. Should parents experience difficulty with payments of fees, parents should make an appointment with the Principal and Business Manager of GSCS to discuss a possible payment plan. Alternatively, parents may apply for means-tested Fee Assistance. Each application will be handled individually on a 'case-by-case' basis and with confidentiality.

Any hardship concessions awarded are only available for that given school year. Therefore, any applications for a hardship concession are to be re-submitted each school year as applicable.
