TUITION FEE POLICIES

Each family will receive their full account for the year in February 2024. All accounts will be sent out electronically.

1. FEE PAYMENT

Step 1: Choose payment option

1. Annually – To be paid via Eftpos or Direct Deposit by 17th February

2. Payment Plan by Westpac PAYWAY - direct debit

Step 2: Set up payment plan with GSCS

- 1. Annual payment due:
 - Friday 16th February 2024
- 2. Per term payments due:
 - Term 1: 16th February 2024
 - Term 2: 19th April 2024
 - Term 3: 19th July 2024
 - Term 4: 11th October 2024

Step 3. Regular payments by Westpac direct debit:

- Payment dates as indicated on direct debit agreement
- First payment to begin in February 2024
- Payments must be weekly, fortnightly or monthly
- Direct debit forms are to be submitted to GSCS by Friday 16th February

Regardless of payment option, all school fees must be paid in full by November 21st, 2024.

2. JOINT AND SEVERAL LIABLILITY FOR TUITION FEES

All parents/guardians, including step-parents, who have signed a Confirmation of Enrolment, are jointly and severally liable for the payment of all fees and other charges related to the education of their student/s at GSCS irrespective of any Court Orders or Child Support Assessments.

3. UNPAID TUITION FEES

Consistently unpaid fees will put the enrolment of your child/ren at GSCS in jeopardy. If an enrolment is discontinued, unpaid fees will still be a debt due and owing to GSCS.

No credit or refund, either in part or in whole, will be provided if the student is absent due to any reason such as illness, leave, enrolment suspension or termination.

If any unpaid account remains outstanding without an approved arrangement with our Finance Officer, we then reserve the right to require such families to enter into a contract of payment as a condition of continuing enrolment. In the event of any account balance being outstanding at the end of the calendar year, GSCS reserves the right to apply a 10% service charge of the outstanding balance of the account.

4. WITHDRAWAL FROM GSCS

GSCS must receive a full term's written notice for the withdrawal of a student at any point in the year, otherwise a full term's fees will be charged in lieu of notice.
